

WORLDSTRIDES BACK-TO-SCHOOL SWEEPSTAKES
OFFICIAL RULES ("Official Rules")

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING THIS SWEEPSTAKES.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

BY ENTERING THIS SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE RELEASED PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

ELIGIBILITY: The WorldStrides Back-to-School Sweepstakes (hereafter, "**Sweepstakes**") is open only to individuals who are: (i) a legal resident of the United States; (ii) legal age of majority or at least eighteen (18) years old, and (iii) a current Teacher at a public or private school located in the United States that educates children between the grades of 6-12. For the purpose of this Sweepstakes, a Teacher is being defined as a professional educator who works with students as a whole class in a classroom, in small groups in a resource room, or one-on-one inside or outside a regular classroom. This includes teachers' aides, administration, athletic directors, coaches and paraprofessionals. Void where prohibited by law. Employees, officers and directors of WorldStrides, Inc. ("**Sponsor**"), teamDigital Promotions, Inc. ("**Administrator**"), and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers, advertising/promotion agencies and their immediate family members (i.e., spouses, parents, children, grandparents, grandchildren and siblings and each of their respective spouses) and/or those living in the same physical address ("household") of any of the foregoing (i.e., people who share the same residence at least three (3) months a year, whether legally related or not) are not eligible to enter or win a prize in this Sweepstakes. Sponsor, Administrator, and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers and advertising/promotion agencies are each a "**Released Party**" and shall hereinafter collectively be referred to as the "**Released Parties**". Winning a prize is contingent upon fulfilling all requirements set forth herein.

PROMOTION PERIOD: The Sweepstakes begins at 12:00:00 a.m. Eastern Time ("**ET**") on 8/10/26 and all entries must be received by 11:59:59 p.m. ET on 9/30/26 (hereafter, "**Promotion Period**"). In addition, the Sweepstakes will consist of seven (7) separate, independent weekly entry periods (each, a "**Weekly Period**") in which one (1) Third Prize winner will be randomly selected from each Weekly Period (for a total of seven (7) Third Prize winners). One (1) Grand Prize winner, one (1) First Prize winner and fifteen (15) Second Prize winners will be selected from all eligible entries received during the Promotion Period. Each "Weekly Period" begins on a Monday and concludes on the following Sunday with the exception of the last Weekly Period which will end on a Wednesday. The Sponsor's designated time clock will be the official time keeping device for this Sweepstakes.

HOW TO ENTER: To enter the Sweepstakes, during the Promotion Period, you may visit the Sweepstakes website at go.worldstrides.com/backtoschool2026. The website will contain a description of the

Sweepstakes and the official entry form. Each entrant will be asked to submit an official entry form, which may include, among other things, his/her full name, address (no P.O. Boxes), email address, phone number, name (and address) of the school he/she works and related registration information as prompted. Entrant must complete and submit the entry form with all required information for the entry to be eligible.

Limit one (1) entry per person and per email address for the duration of the Promotion Period. In the case of multiple entries from any one (1) person and/or email address, only the first entry received will be accepted and all subsequent entry attempts from such person for that will be void. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified.

All entries become property of Sponsor and will not be returned. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and will be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Sponsor and the other Released Parties are not responsible for lost, incomplete, late, misdirected, delayed, garbled, damaged, inaccurate, stolen, or mutilated entries; theft, destruction or unauthorized access to, or alteration of, entries, failures or malfunctions of phones (including wireless phones/handsets), phone lines, cellular equipment towers, telephone systems, lost entries, text messages or transmissions, defect or delay in transmission, transaction processing, interrupted or unavailable network, server, wireless service provider or other connections; any error, omission, interruption, defect or delay in transmission, 3rd party transaction classification, transaction processing, or communication; traffic congestion on the Internet or any technical problem, including, but not limited to, any injury or damage to entrant's or any other person's computer related to or resulting from Sweepstakes participation, technical or mechanical malfunctions; failures or malfunctions of phones (including wireless phones/handsets), phone lines, cellular equipment towers or telephone systems; interrupted or unavailable network, server or other connections; errors or omissions in these Official Rules, in any Sweepstakes-related advertisements or other materials; and any other errors or problems in connection with this Sweepstakes, including, without limitation, errors or problems in connection with the administration of the Sweepstakes, the processing of entries, in the selection or announcement of the winners or in awarding of the prize; human-processing error; failures of electronic equipment, computer hardware or software; or inaccurate entry information, whether caused by equipment, programming used in this Sweepstakes, human error, or otherwise. Use of any device to automate or subvert entry is prohibited and any entries received by such means will be void. No software-generated, robotic, programmed, script, macro or other automated entries are permitted, and any entries received by such means will be void. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age, residence and occupation) are void. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry. Winners may be required to show proof of being the registered account holder. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider or other organization responsible for

assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Other than as otherwise specified herein, neither Sponsor, nor anyone acting on its behalf, will enter into any communications with any entrant regarding this Sweepstakes (except for the purposes of notifying the potential winners) or acknowledge any entry (or portion thereof) received.

WINNER SELECTION/ODDS:

GRAND, FIRST & SECOND PRIZE WINNERS: Potential Grand, First & Second Prize winners will be selected in a random drawing by Administrator, on or about 10/2/26 from among all eligible entries received. All decisions by Administrator and Sponsor will be final and binding in all matters relating to this Sweepstakes. The potential prize winners will be notified by Administrator after the drawing by email, text message and/or mail within a reasonable amount of time (as selected by Administrator in its sole discretion). Odds of winning a Grand, First or Second Prize will depend on the total number of entries received during the Promotion Period.

THIRD PRIZE WINNERS: For each Weekly Period, one (1) Third Prize winner will be selected in a random drawing conducted by Administrator, on or about 10/2/26, from among all eligible entries received for the applicable Weekly Period. **Entries received during each Weekly Period will carry forward to and be included in subsequent Weekly Period drawing(s). All Weekly Period entries received during the Promotion Period will be included in the Grand, First & Second Prize Drawings.** Odds of winning a Third Prize will depend upon the total number of entries received for each applicable Weekly Period.

Potential Prize winners will be required to execute and return an Affidavit of Eligibility and a Release of Liability and (where legal) a Publicity Release within five (5) days of date of issuance of notification. The potential prize winners' respective schools may also be required to consent in writing to their participation in the Sweepstakes and award of any prize and Sponsor's and each of its designees' use of such school's name, location, trademark, mascot and/or logo until May 2029 in any and all media now known or hereafter devised, worldwide, without compensation (unless prohibited by law). In addition, a school representative may be required to sign certain documents required by Sponsor within five (5) days of date of issuance in order for the school to receive the applicable school prizing components. Second and Third Prize winners will receive their prize within 8 weeks at the address designated on their official entry form. In the event of noncompliance with these Official Rules, the determination that a potential prize winner or his/her school cannot accept a prize, or if a potential prize winner or their related school representative fails to properly complete and submit the above-described documents, Sponsor may disqualify such potential prize winner and an alternate potential prize winner will be randomly selected and notified. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. Subject to verification of eligibility and compliance with these Official Rules, the potential winners will be declared the official winners of the Sweepstakes. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in potential prize winner's email account to receive email messages.

PRIZES: ONE (1) GRAND PRIZE: Educational dream trip to be awarded to the school identified on the

winning entry ("**Trip**"). Trip consists of round-trip transportation, standard hotel accommodations, admission per itinerary and select meals per itinerary. Maximum approximate retail value ("**ARV**") of Grand Prize: \$100,000. **ONE (1) FIRST PRIZE:** A \$10,000 grant awarded to the school identified on the winning entry. ARV of First Prize: \$10,000. **FIFTEEN (15) SECOND PRIZES:** The Teacher identified on each winning entry will have their choice of one of the following \$500 gift cards: Teacher's Discovery, Carolina Science Supplies, Teachers Pay Teachers or J.W. Pepper. ARV of each Second Prize: \$500. **SEVEN (7) THIRD PRIZES (one (1) prize per Weekly Period):** The Teacher identified on the respective winning Weekly Period entry will receive a tote bag, a water bottle and their choice of one of the following \$100 gift cards: Carolina Science Supplies, Teacher's Discovery, Gopher Sport, Teachers Pay Teachers or J.W. Pepper. ARV of each Third Prize: \$210.

Terms, conditions and restrictions on gift cards may apply, as designated by issuer. Gift cards may be awarded as a physical card, certificate or digital code, as designated by issuer. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Released Parties will have no further obligation with respect to that prize or portion of the prize. All costs and expenses associated with the acceptance and use or misuse of the prize not specified herein as being awarded, including, but not limited to, all federal, state and local taxes, are winner's sole responsibility. \$10,000 grant to be awarded in the form of a check made payable to the school identified on the winning entry. The ARV of the prize is based on available information provided to Sponsor and the value of any prize awarded to a winner may be reported for tax purposes as required by law. The ARV of each prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded. Trip Details: Trip must take place between June 1, 2027 and November 30, 2028 or prize will be forfeited in its entirety. A single destination must be chosen from the list provided by Sponsor (custom programs are not part of this prize as awarded). Trip prize cannot be used toward an already-actualized trip (defined as a trip for which at least one student has already signed up/enrolled prior to the start of the Promotion Period). Total value of Trip may not exceed \$100,000. Winning school must travel on the itinerary agreed upon with Sponsor and under Sponsor's terms and conditions (for both the school and individual trip participants). Winning school is solely responsible for obtaining all required travel documents, including Real ID, valid passport, etc. with at least six months' validity beyond the travel dates, and any necessary Visas from all individuals participating in Trip. The number of individual trip participants, including the program-leading teacher and any/all adult chaperones, will be determined by the winning school based on the scope of the awarded trip, provided that the ratio of adult chaperones to student participants must comply with Sponsor's then-current standard chaperone ratio requirements for the applicable trip type and destination. Winning school is solely responsible for ensuring that any state or district risk management or compliance requirements for participants regarding background checks or clearances are met within the time period set for determining the identity of all trip participants. All expenses and incidental travel costs not expressly stated herein, including but not limited to additional meals, gratuities, baggage fees, personal expenses, travel insurance, and applicable taxes, are the sole responsibility of the winning school or individual trip

participants. Sponsor is not responsible for cancellations, delays, or interruptions due to weather, acts of God, government restrictions, public health concerns, or other factors beyond its control. In such event, Sponsor reserves the right, in its sole discretion, to substitute a prize of equal or greater value or modify the Trip components. Any trip participant who either cancels their registration, or does not attend the entirety of the trip, for any reason whatsoever, will not be granted a cash refund of any kind. In addition, if a participant cancels their registration fewer than one hundred fifty (150) days prior to the scheduled trip departure date, the participant (or, if the participant is a minor at the time of cancellation, the participant's parent or legal guardian) will be responsible for reimbursing the Sponsor for any non-refundable trip-related expenses already incurred on their behalf as of the date of cancellation, including but not limited to airfare, lodging, tour operator, and vendor deposits or fees. Cancellations made one hundred fifty (150) days or more prior to departure will not incur this reimbursement obligation. Sponsor reserves the right to invoice the responsible party — the participant if an adult, or the participant's parent or legal guardian if the participant is a minor — directly for such amounts. The Grand Prize is non-transferable, non-refundable, and no substitution or cash equivalent is permitted, except at Sponsor's discretion.

Total ARV of all prizes to be awarded in this Sweepstakes: \$118,970.

PRIVACY: Completing the entry form at either go.worldstrides.com/backtoschool2026 constitutes your consent to enter and participate in this Sweepstakes and your consent for Sponsor and Administrator to obtain, use and transfer your name, email address, mailing address, phone number, name (and address) of the school you work and other information provided by entrants in connection with this Sweepstakes (collectively, "**Sweepstakes Data**") for the purpose of administering this Sweepstakes, awarding the prizes and to comply with applicable legal requirements. Any information entrant provides may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winner's list.

Except where prohibited by law, acceptance of a prize constitutes each winner's irrevocable consent to Released Parties, and each of their respective agents', successors', assigns' and other designee's use of each winner's name, likeness, photograph, voice, statement, opinions, biographical information, prize and/or state/city of residence for advertising and promotional and publicity purposes in any and all media or format, worldwide, in perpetuity, without any permission, notification, payment or consideration, except for the awarding of the prizes to the winners. You may be required to sign a document confirming your consent to this effect. LIMITATION OF LIABILITY: BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANT'S REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

CHOICE OF LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of an entrant and the Released Parties in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the Commonwealth of Virginia, USA, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's law.

ARBITRATION: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that: (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or any prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held in Albemarle County, Virginia; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Virginia. The Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the

arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

MISCELLANEOUS: No transfer, assignment, cash redemption or substitution of a prize (or portion thereof) will be permitted, except by Sponsor, in its sole discretion, due to prize unavailability or other causes otherwise determined solely by Sponsor, and then for a prize (or applicable portion) of equal or greater value. By participating, entrants agree to be bound by these Official Rules and agree that Released Parties and each of their respective designees and assigns and all of their respective officers, directors, employees, shareholders, representatives, agents, and the franchisees of any of them shall have no liability and entrant will defend, indemnify, release and hold harmless Sponsor and the other Released Parties from and against any liability, loss, injury, or damage of any kind (including attorneys' fees) to any person or entity, including, without limitation, personal injury, death or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of: (i) entrant's participation/entry into the Sweepstakes; (ii) any materials he or she may submit in connection herewith; (iii) the acceptance, possession, use or misuse of a prize (or any portion thereof) or participation in any activities associated with the Sweepstakes or any prize (or any portion thereof) awarded in connection herewith; (iv) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; and (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize. The Released Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent these Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness, or proper play of this Sweepstakes and to modify, suspend, and/or terminate this Sweepstakes (or portion thereof) should virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Sweepstakes and, in the case of termination, at its discretion, select potential winners via a random drawing from among all eligible, non-suspect entries received before the event that required such modification, termination or suspension. In the event Sponsor or Administrator is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, large-scale illness, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's and/or Administrator's control (each, a "**Force Majeure**" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor may decide to postpone the drawing date and other deadlines herein or terminate the Sweepstakes early. In the event the Sweepstakes is terminated early, Sponsor shall immediately suspend the drawing(s) and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total ARV as set forth in these Official Rules) in a manner deemed fair and equitable by Sponsor. Sponsor shall not have any further liability to any participant in connection with the Sweepstakes. Sponsor and Administrator additionally reserve the right, in their sole and absolute discretion: (a) to amend, modify, suspend or terminate the Sweepstakes should a Force Majeure event corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b)

to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an unsportsmanlike manner. CAUTION: Any attempt to undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws and should such an attempt be made, the Sponsor and the applicable Released Parties reserve the right to seek damages (including attorneys' fees) and/or other remedies from any such person(s) responsible for the attempt to the fullest extent permitted by law. The Sweepstakes and all prizes are provided "as is" and Released Parties make no warranty, guaranty or representation of any kind concerning any prize (or any portion thereof) and disclaim any implied warranty. Some jurisdictions do not allow the disclaimer of implied or other warranties so the above disclaimer may not apply to you to the extent such jurisdictions law is applicable to you and these Official Rules.
